Minutes of the Culture Preservation Committee Meeting

August 5th, 2025

Present: Levi Randoll, Jason Jones, Alicia Rezendes, Jim Rementer, and Gretchen Williams were present. Tristen Tucker was present via Zoom, due to traveling. Martina was absent due to illness. Sarah Boyd attended as a guest.

The meeting was called to order at 5:45 p.m. by Levi Randoll.

A prayer was given by Alicia . Roll call was taken.

#1.) Alicia made a motion to excuse Martina's absence.

Next we reviewed the agenda.

Gretchen shared that she had a lot of brisket that she would like to donate to Saturday's meal, and for everyone to just bring a side dish.

Tristen then spoke on wanting to bring back coals from the pure fire to individual camps and teaching the cultural significance of doing so to tribal members.

We then created a list of everything we would need to organize for Delaware Days. Including getting a quote on porta potties, Jason providing tiki torches for lights, getting an honor blanket for Friday night, as well as one for the first place winner of the Messenger Race. Gretchen said she would check with Kendall about the electricity being used, being charged to Luana's home. And reach out to Leslie for honor blankets and shirts for Delaware Days. We also talked about moving the football game to the other side of the house.

Next we talked about when we would hold our next Dance Practice. We decided on having it on August 21st, and to feed spaghetti.

Our next meeting will be held on Sept. 2nd at 5:30 pm in the FCS building.
