Connie Falleaf will submit artwork for the banner or banners. The banners will be double-sided, if possible and the colors will be a white background with red lettering. The banners will be used during parades as well as other events.

- Awarded one time per year but an award is not required each year and awards shall be at least 12 months apart **if** a nominee is selected by the committee.
- Recipients must be a DTI tribal member.
- The nominee must be exceptionally outstanding in the advancement of our Lenape culture and history.
